- I, Mrs. Grishma Khandwala, Company Secretary in Practice have been appointed as the scrutinizer of SUNRAJ DIAMOND EXPORTS LIMITED pursuant to Section 108 and Section 109 of the Companies Act, 2013 read with Rule 20 and Rule 21 of the Companies (Management and Administration) Rules, 2014, and pursuant to Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 for the purpose of:

The Management of the Company is responsible to ensure compliance with the requirements of the Companies Act, 2013 and the Rules relating to voting by electronic means and poll for the resolutions contained in the Notice of the 29th AGM of the Equity Shareholders dated 13th August, 2019. My responsibility as a Scrutinizer for the remote e-voting process and for polling process is restricted to making a Consolidated Scrutinizer's Report of the votes cast "in favour" or "against" the resolutions stated in the notice of the AGM, based on the reports generated from the remote e-voting system provided by National Securities Depository Limited (NSDL), the Agency authorised under the Rules and engaged by the Company to provide e-voting facilities for voting through remote e-voting and based on the physical votes cast by ballot by Members/Proxies at the AGM.

The Notice dated 13<sup>th</sup> August, 2019 convening the AGM was sent to the shareholders in respect of the below mentioned resolutions to be passed at the AGM of the Equity Shareholders of the Company.

The Company had availed the remote e-voting facility offered by National Securities Depository Limited (NSD) for facilitating remote e-voting to the shareholders of the Company and had also provided poll voting process to the shareholders who attended the AGM and who had not voted electronically.

The Shareholders of the Company holding shares of the Company as on the "cutoff" date of 23<sup>rd</sup> September, 2019 were entitled to vote on the resolutions as
contained in the Notice of AGM of the Company.

The period for remote e-voting commenced on Friday 27<sup>th</sup> September, 2019 at 9.00 a.m. and ended on Sunday 29<sup>th</sup> September, 2018 at 5.00 p.m.

On 29<sup>th</sup> September, 2019, after the end of the remote e-voting period i.e. 29<sup>th</sup> September, 2019, at 5.00 p.m., I was provided access to details of the members who had opted for e-voting. The details such as the name of the member, folio no. and number of shares held by the member could be seen to ensure that these members do not vote again at the AGM. However the manner in which the votes were cast by the members were not available.

Further, the Chairman announced that facility for voting through ballot paper was available at the AGM venue for the shareholders who attended the meeting and had not cast their vote earlier through remote e-voting.

The voting results were diligently scrutinized and were reconciled with the records maintained by Adroit Services Private Limited, Registrar and Transfer Agent of the Company and the authorisations/proxies lodged with the Company.

I have scrutinized and reviewed the remote e-voting and votes tendered therein based on the data downloaded from the e-voting website of NSDL and also the voting results during the poll process at the AGM.
